2. Bids received in excess of the ABC shall be automatically rejected during the bid opening.
3. Bidding will be through public bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulation (IRR) of RA 9184.
4. Eligible bidders are Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
5. **Pre-Bid Conference** will be held on **August 30, 2022 (Tuesday), 11:30 AM** at Conference Room, Headquarters Maritime Group, Camp BGen Rafael T Crame, Quezon City.
6. Bids must be received by the Secretariat, MG BAC at the office address indicated below on or before September 12, 2022 at 10:00 AM. Late bids shall not be accepted.
7. All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in Instructions to Bidders Clause 14.

8. **Bid opening** shall be on **September 12, 2022 (Monday) 10:00 AM** at the Conference Room, Headquarters Maritime Group, Camp BGen Rafael T Crame, Quezon City. Bids will be opened in the presence of the bidders or their representatives who choose to attend the activity.

The PNP Maritime Group reserves the right to reject any or all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA 9184 without thereby incurring any liability to the affected bidder.
